## **Timberline Community Club Board**

April 18, 2017 meeting minutes

- 1. The meeting was called to order at 7:14. Present: Kelly Lyon-King, Ben Coffin, Kathe Low, Anna Yung, Mike Barham.
- 2. Reviewed and approved March 2017 meeting minutes.
- 3. Active Committee Reports
  - a. Financial
    - i. Kelly signed premium audit for Liberty Mutual Insurance (liability insurance)
    - ii. Have not yet received Republic bill. Waiting.
    - iii. Kelly to invite Timberline Park board to future meeting. TP had questions regarding landscaping bills.
    - iv. Agreed to fully repair broken mailbox at 20512 NE 34th PL using Lockbox NW (proposal was estimated to be between \$250-\$300)
  - b. Michael CAM Update
    - i. Plum trees pruned. Entry sign and walkways pressure washed. Bills paid.
    - ii. Common Area Entrance Maintenance

Juniper hedge trimmed and surrounding beds raked and cleared at south corner of Sahalee and 37th Way. This area falls on the board with the City, though is poorly maintained and the hedge created a visual and physical obstruction on the sidewalk.

Arborvitae hedge at 208th and 37th Way trimmed on 4/12/17.

The trash container at the same location will be moved 200 feet around the corner near the Dog Bags – this will improve driver visibility and aesthetics of the entrance.

Lighting at monument – this will be complete by 4/22. Scope includes replacement of bulbs and installation of taller lights

Planting at the monument – Michael has requested a bid from ProGrass – at a minimum we will have seasonal flowers planted by 4/22

iii. Bark of common area beds and entrance

Bark King will complete this work no later than this first week of May (they are very busy). Pacific Top Soil was not helpful when Michael reached out to them. Bark will be blown in and will have a very clean and professional look. Key that it is being done AFTER the pressure washing.

Project cost estimated at \$1,400 – still waiting on final scope and bid. Given that this has not been done for years, worth the investment as the work with be comprehensive (3 inches / medium bark throughout)
